### WATER USER'S AGREEMENT

THIS AGREEMENT, made and entered into by and between RANDALL COMMUNITY WATER DISTRICT, a public corporation formed under SDCL 46A-9 (hereinafter called RCWD), whose address is 445 Main Street - PO Box 37, Lake Andes, South Dakota, and

WHEREAS RCWD has been formed for the purpose of constructing or acquiring a water system to distribute potable water from the Lake Francis Case Reservoir and other sources to rural homes, pastures, feedlots, and elsewhere as deemed feasible; and WHEREAS USER has made application to, or desires to purchase water from, RCWD; and WHEREAS, RCWD has received a hook-up fee, accompanied by a WATER USER APPLICATION, wherein the Applicant agreed to enter into, and become bound by, this WATER USER'S AGREEMENT;  
NOW, THEREFORE, it is hereby understood and agreed as follows, to-wit:

1. RCWD shall furnish Water to USER, to be delivered to a tap located upon the following described property, in \_\_\_\_\_ County, South Dakota. Legal Description: \_\_\_\_\_
2. The tap located on the above described property, and to which this AGREEMENT applies, is:
  - Rural Farmstead. A tap from which water is used for household purposes in an inhabited dwelling, and from which livestock may also be watered.
  - Rural Pasture. A tap from which livestock is watered, and is not used for human consumption or other household purposes. 3 gpm restriction.

3. The water delivered to USER shall meet applicable purity standards of the State and National Governments, in such quantity as may be required by USER, within the limits of RCWD to produce the same.
4. USER agrees to pay RCWD for the water purchased by him at a rate and at such times and places as shall be determined by RCWD, according to the Schedule of Rates attached to the By-Laws and Rules and Regulations of RCWD, as the same may be amended.
5. USER acknowledges receipt of a copy of said By-Laws and Rules and Regulations, and agrees that the terms and conditions contained therein shall be incorporated in, and become a part of, this AGREEMENT, the same as if set forth in full herein. Any changes made in the Schedule of Rates shall become a part of this agreement as though fully set out herein.
